# Purpose

To ensure all persons engaged with the SAAA as Members or otherwise are aware of and understand the legal basis for defining the way in which SAAA operates.

### Scope

Description of the legal instruments and their precedence in respect of each other and any policies, procedures, guidelines, manuals or similar established by SAAA

# Prerequisites

- a. Legal instruments
  - i. The Act the Associations Incorporation Reform Act 2012 or equivalent prevailing
  - ii. The Rules under section 46 of the Associations Incorporation Reform Act 2012, the prevailing Rules constitute the terms of a contract between the Association and its Members. (The Rules are often referred to as The Constitution)
- b. Documents of the SAAA policies & procedures, guidelines, manuals or similar established by SAAA

# Responsibilities

- a. Ensure that SAAA and its Members act in accordance with the legal instruments Office Bearers
- b. Act in accordance with the legal instruments all Members of the SAAA and others engaged by SAAA
- c. Notification to SAAA Members and others engaged by SAAA of changes to the legal instruments the Administration Support Service Provider (Office) through the Hon. Secretary (SEC)

### Procedure

- 1. On the introduction of a new Member to the SAAA, the new Member must within the "New Member Pack", or as this might otherwise be known, be informed of the existence of and reference to the prevailing legal instruments (the Act and the Rules).
- 2. On the appointment of a National Councillor, technical or administrative support advisor or service provider, the appointee or senior authorised representative of an appointed service provider must execute an acknowledgement that they have received, read and understood the prevailing legal instruments.
